This year our membership was offered a wide variety of educational programs, new opportunities to contribute in the service of others, and several social events to promote community within our organization.

I first thank Neil Ferraro, the BPLA Activities Chair for 2003, for his friendship and unwavering support of our vision for the organization. I also thank the Officers and Board of Governors of the BPLA for their active participation on behalf of the organization, for their advice in planning events, and for their support in their respective roles: President-Elect, Peter Corless; Vice President, Doreen Hogle; Treasurer, Ingrid Beattie; Secretary, Lee Bromberg; and Board Members, Leslie Meyer-Leon, Mark Solomon, and Lisa Michaud.

This fall, and through the end of the year, the organization will continue to provide a wide variety of informative programs. Since my last report, the BPLA hosted a presentation on September 3 by Maria Eliseeva, from Houston Eliseeva, on Conducting Business Electronically with the USPTO and WIPO. This informative session was well attended and provided attendees with the latest information on electronic patent filings. On September 17, the BPLA Licensing Committee

sponsored a program on Licensing Royalty Audits and Bankruptcy Issues, presented by Martina Rozumberkova from Tofias, P.C., and David McIntosh from Ropes & Gray. This session provided useful insights and practical advice in IP licensing transactions.



The annual BPLA Advanced PCT Practice Seminar was held on October 16-17. The Seminar was given by Louis Maassel from WIPO, Carol Bidwell from the USPTO, and David Reed from Procter & Gamble. The speakers provided their perspectives on new rules and forms required in PCT practice effective in 2004. Finally, on October 16, the Trademark and Unfair Competition Committee hosted A Discussion and Analysis of Foreign Trademark Protection: Community Trademark v. Madrid Protocol. This presentation, by John Olsen from Field Fisher Waterhouse (London) and Vincent O'Reilly, from the Office for Harmonization in the International Market (OHIM) (Alicante, Spain), provided useful practice information and strategies to trademark practitioners now confronted with a new foreign filing alternative. Also, as we have tried to do throughout the year, the BPLA hosted a social event for members to get to know one another. The latest event was the BPLA Fall Festival on September 27 at the Nashoba Valley Winery and Orchard. In this same spirit, I am pleased to report that the Young Lawyers Committee hosted an after work social on September 17, and plans to hold another similar event on November 5.

MINUTES OF THE BPLA ANNUAL MEETING December 4, 2002

1. Call to Order and Introduction. The Annual Meeting was called to order by President William G. Gosz at 12:30 p.m. at the Seaport Hotel in Boston. President Gosz introduced the head table, introduced past BPLA presidents in attendance, and introduced special guest Yardley Chittick. President Gosz then presided over a moment of silence in recognition of deceased members Robert Gammons, Tony Lorusso, Stan Sacks, and Richard Testa. President Gosz then recognized new members of the Association. Approximately 240 persons were in attendance at the Annual Meeting.

2. Presentation of Writing Competition Awards. Lee Bromberg presented the 2002 Writing Competition Awards. First Place Prize and check were presented to Stephen R. Wilson. Second Prize was awarded to Shannon M. Sidie, who was unable to attend the Annual Meeting.

3. President's Report. President Gosz reported on the very successful year that the BPLA had during 2002 and presented awards to Committee Chairs.

4. Report of Secretary. Secretary Ingrid Beattie was absent due to illness and President Gosz reported in her stead. A motion was made, seconded and passed to waive the

reading of the minutes of the December 12, 2001 Annual Meeting, which had been distributed to the membership prior to this year's meeting, and to adopt the minutes as printed.

5. Report of the Treasurer. Treasurer Doreen Hogle reported on balances in the checking account and the saving account, and noted that during a busy year of BPLA activities, the BPLA net income for the year was running at just over \$6,000, close to the budget. The Treasurer's Report was adopted on motion without objection.

6. Speech of Director James Rogan. President Gosz introduced the Honorable James E. Rogan, Director of the United States Patent and Trademark Office Operations. Director Rogan delivered a stimulating speech on his plans and efforts to modernize and streamline PTO procedures to reduce average pendency for patent applications and to encourage more effective evaluation of applications during the process, while at the same time recognizing budgetary restrictions.

7. Report of the Nominating Committee. Tom Engellener, as Chair of the Nominating Committee, reported the Committee's recommendation for appointment of the following Officers and Members of the Board of the Board of Governors for 2003:

President Lando made available a handsome card listing 2003 Boston Patent Law Events on one side, and Officers, Boards and Committees on the other, which was well received by the members.

9. Adjournment. After the business of the Annual Meeting had been completed, and upon motion duly made and seconded, it was voted, without objection, to adjourn the 2002 Annual Meeting.

CONDUCTING BUSINESS ELECTRONICALLY AT THE PATENT OFFICE

The USPTO and WIPO now welcome and encourage conducting business electronically. Most transactions traditionally performed by mail can now be performed electronically and such transactions are not limited to e-filing of patent applications.

On September 3, 2003, Maria Eliseeva of Houston, Eliseeva, LLC presented an informative session to a sell-out audience on electronic transactions now available. Ms. Eliseeva demonstrated filing utility and

recordable documents, such as Assignments.

The session also covered the use of PAIR (Patent Application Information Retrieval) System, both Private and Public, Rule on e-IDS and Paper IDS Submitted on the Same Day, Overview of Available Private Vendors' Authoring/Submission Tools and Useful Tools and Tips.

Ms. Eliseeva is the Chairperson of the AIPLA Committee on Electronic Business

Automation and Harmonization of Standards, is one of the top e-fillers in the US and regularly speaks on this topic.

LICENSING ROYALTY AUDITS AND BANKRUPTCY ISSUES

On September 17, 2003 the Licensing Committee held a seminar titled "Licensing Royalty Audits and Bankruptcy Issues" at the Boston Harbor Hotel. Guest speakers were Martina Rozumberkova, senior consultant, and David Sullivan, partner, at Tofias, P.C., the largest regional accounting and consulting firm in New England, and David McIntosh, of Ropes & Gray's Corporate Department and Intellectual Property & Technology Practice.

Ms. Rozumberkova and Mr. Sullivan discussed royalty underpayments, stating that underpayments are

often unintentional, due to poor internal control, poor communication or ambiguous language in the licensing agreement. However, it is important that the company/institution is receiving all of the royalty they are entitled to under the licensing agreement and royalty audits can ensure complete, timely and proper reporting. Some key issues and considerations to ensure proper royalty payments include designating a single person to be in charge of royalty calculations and reporting; using adequate accounting software; and instituting systems to identify royalty bearing sales and to identify derivative products with royalty bearing technology. Roy-

alty audits take much preparation and planning, but the costs of royalty audits can be managed by clearly defining the scope of the audit and testing procedures.

Mr. McIntosh shared strategies for structuring licensing agreements to avoid some common pitfalls due to language ambiguities, and in particular emphasized drafting agreements to protect the non-bankrupt party in the event that either the licensor or licensee files for bankruptcy court protection. Mr. McIntosh summarized provisions of the U.S. Bankruptcy Code and discussed recent cases related to bankruptcy concerns.

ADVANCED PCT SEMINAR

On October 16 and 17, Louis O. Maassel, consultant to the PCT Legal Division of the World Intellectual Property Organization; Carol Bidwell, supervisor for the Office of PCT Legal Administration of the U.S. Patent & Trademark Office; and David Reed, manager of Global Patent Services, Procter & Gamble Corp. spoke to attendees at the annual PCT Seminar.

This seminar covered aspects of PCT practice from filing of the original PCT application, through International search, publication, prelimi-

nary examination and entry into the National/Regional stage. Strategies for use of the PCT as part of a comprehensive program for protection of patent rights in the U.S. and foreign countries were also addressed, with particular attention to issues of importance and concern to U.S. practitioners.

Importantly, the PCT practice changes to take effect in January 2004 were also discussed.

COMMUNITY TRADEMARK (CTM) v. MADRID PROTOCOL

On Thursday October 16, at the Marriott Boston Cambridge Hotel, the Trademarks and Unfair Competition Committee presented a seminar on foreign trademark protection. Guest speakers were John Olsen, head of the Trade Mark and Brand Protection Group at Field Fisher Waterhouse in London, England, and

Vincent O'Reilly, director of the Trade Mark and Designs Department of the Office for Harmonization in the Internal Market in Alicante, Spain. Since the United States accession to the Madrid Protocol, strategies for obtaining foreign trademark protection has changed. The speakers discussed some of the features and benefits of registration

under the Community Trademark and Registered Community Design systems as well as registration under the Madrid Protocol. Common issues pertaining to these forms of protection were highlighted and some practical tips for U.S. trademark practitioners were provided.

H.R. 1561, THE U.S. PATENT AND TRADEMARK FEE MODERNIZATION ACT OF 2003

In the spring of this year, House Representatives Smith and Berman introduced H.R. 1561 in Congress. Key provisions of the Bill included an increase of Patent Office fees, for example, for filing and examining applications, excess claims fees and excess page fees. The increase in user fees is seen by many as necessary to fund improvements in the PTO patent prosecution system to ensure quality examination of patent applications in a timely manner. A key provision of the Bill ends the

practice of diverting PTO user fees away from the PTO to fund other non-patent/trademark government programs. Over the last 12 years, over \$650 million of PTO-generated fees have been taken away from the PTO through the annual appropriations process. Mr. Herb Wamsley, Executive Director of the Intellectual Property organization (IPO) has issued an alert to all IP practitioners that H.R. 1561 is in danger of not passing this year, or if passed, the key provision to eliminate diversion of

PTO funds may be excluded from the final version of the Bill. This means that PTO user fees could be increased from 15-25% without any guarantee that this increased revenue would be retained for PTO improvements. Mr. Wamsley, our guest speaker for the Annual BPLA Meeting in December, will address these issues. However, Mr. Wamsley, on behalf of IPO, urges all IP practitioners to contact their government officials and lobby for passage of H.R. 1561.
